
DAILY UPDATE 1 : IMPORTANT DAY


### DAILY UPDATE 2 : IMPORTANT DAY


### **DAILY UPDATE 4 : APPOINTMENT**



India's Ministry of Ports, Shipping, and Waterways (MoPSW) has named Manu Bhaker, a double Olympic medalist, as a brand ambassador. Bhaker, a shooting ace who won medals at the recent Summer Olympics in Paris, is the daughter of a marine engineer. Speaking after the signing, Sarbananda Sonowal, Union Minister, MoPSW, said: "It is a moment of great pride for every Indian; and for every member of India's maritime sector. Manu Bhaker, the daughter of a proud marine sailor, is now going to champion the marine sector of India as she has been officially signed as the Brand Ambassador of the Ministry."

#### Mohammad Shafi Pandit, First Muslim IAS Officer From Kashmir Valley, Passed Away :-

The first Muslim IAS official from Jammu and Kashmir, Mohammad Shafi Pandit, died on September 19. He was eighty. Pandit was being treated at a hospital in Delhi after being diagnosed with cancer roughly a month earlier. Pandit made history in 1969 as the first Muslim from Jammu and Kashmir to pass the civil service tests. He finished his official career as the head of the autonomous Jammu and Kashmir Public Service Commission. In the bureaucratic circles, Pandit was widely viewed as a chief secretary that Jammu and Kashmir never had.

### DAILY UPDATE 10 : STATE



#### **Uttarakhand Enacts Landmark Property Damage Recovery Act :-**

Uttarakhand Governor Lt Gen (Retd) Gurmit Singh has signed legislation allowing for complete restitution of damages caused to public property during riots or protests, as well as imposing a punishment of up to Rs 8 lakh on rioters. The Uttarakhand Public and Private Property Damage Recovery Bill was passed by the state parliament last month and forwarded to the governor for approval. Welcoming the governor's assent, Chief Minister Pushkar Singh Dhami said the law's strict provisions would serve as a strong deterrent for potential offenders who damaged public property during strikes, protest demonstrations or riots.
